### FEES AND OTHER COSTS

#### Full 2 week Course - 21 Oct - 1 Nov 2019

Tuition Fees for the two week course including a choice of a specialized module is USD \$4050 The tuition fee includes travel on schedule visits and optional hands-on computer based skills workshops.

### Evidence-building for "Social Protection Plus" - 28 Oct - 1 Nov 2019

To attend the five-day specialized module: Evidence-building for "Social Protection Plus" tuition fees is USD \$2300. The tuition fee includes travel on schedule visits and optional hands-on computer based skills workshops.

### ACCOMMODATION

The comprehensive accommodation is inclusive of accommodation in a four star facility, three meals per day and teas, per diems, airport transfers, use of included facilities and recreational activities and tours. The fees do not include international travel to and from Chiang Mai, Thailand. The fees breakdown are as follows:

- Two week course USD \$2200 (13 nights accommodation)
- One week course USD \$1200 (6 nights accommodation)

For those participants who wish to arrange their own accommodation, the course facilities fee is USD \$730 for the two week course and USD \$405 for the one week course. The facilities fee covers your conference package and associated elements.

### EARLY BIRD AND ADVANCE DISCOUNTS

**Early Bird Discount:** A USD \$200 early bird discount off the tuition fees is available to participants who pre-enrol for the full two week course at least three (3) months prior to the start date of the course. To qualify, applications and payments must be made by the **30 June 2018**. Enrolments received after the early bird deadline are subject to either advance discount or standard fees.

**Advance Discount:** A USD \$100 discount off tuition fees is given to participants who enrol and pay at least six (6) weeks prior to the start date of the course. To qualify, applications and payments must be made by the **31 July 2018.** Enrolments received after the advance deadline are subject to standard fees.

### GROUP BOOKING DISCOUNTS

## ABOUT THE COURSE

Around the world, developing countries are increasingly recognising the value of social transfer programmes in reducing extreme poverty, with success stories in Africa, Asia, and Latin America. The Economic Policy Research Institute (EPRI), together with the UNU-MERIT/ Maastricht Graduate School of Governance and the Institute of Development Studies (IDS) are offering a first of its kind intensive oneweek specialised module aimed at providing participants with the skills and tools to effectively design, implement and monitor "Social Protection Plus" programmes so as to promote sustainable livelihoods and achieve complex developmental outcomes.

### WHO IS IT FOR?

The course aims to build the capacity of government policymakers and officials, representatives from bilateral and multilateral agencies, programme practitioners and staff members from nongovernmental organisations. The course will serve those who want to more effectively design, implement and manage social protection systems with the goal of reducing poverty and better achieving the Sustainable Development Goals.

### HOW PARTICIPANTS WILL BENEFIT

At the end of this course, participants will leave with a holistic understanding of what "Social Protection Plus" is, the complex development impacts that "Social Protection Plus" programmes can enable and the key role of strengthened monitoring and evaluation systems in aiding more effective programming. Participants will benefit from an in-depth and practical understanding of how "Social Protection Plus" programmes can be designed and implemented so as to promote sustainable livelihoods and achieve complex developmental outcomes. The module will draw upon successful international case studies which will be applied within an evidence building framework - identifying workable approaches for different country contexts and highlighting the role of a strong evidence base as a key policy tool. A team of international experts, skilled professionals and leaders in the field will teach the course.

At the end of the program, those who successfully complete the course will earn a Certificate jointly accredited by the Economic Policy Research Institute and UNU-MERIT/Maastricht Graduate School of Governance

## WHAT THE COURSE WILL COVER

The first five days of the course includes a coordinated series of theme-oriented sessions, practical skills-building workshops, field trips to visit Thailand's Social Protection Plus sites and relevant technical skills training. The course will be taught using formal lectures, practical case studies and hands-on exercises.

This module will aim to answer six key questions:

- 1. What is "Social Protection Plus"?
- 2. Why are governments demanding more from their social protection systems?
- 3. How can social protection systems be more effectively integrated with social services, livelihoods, climate change initiatives and shock-resilience?
- 4. How can M&E systems better enable the more appropriate design and more effective implementation of "Social Protection Plus?
- 5. How can macro evidence-building approaches better support more comprehensive and integrated social protection systems that build synergies with social and economic sectors, better strengthening inclusive social development and equitable economic growth?
- 6. How can "Social Protection Plus" better achieve complex outcomes including improving nutrition, expanding youth development opportunities, and strengthening more sustainable and sustaining livelihoods?

This five-day course is being offered as an elective for the wider twoweekcourse"DesigningandImplementingSocial Protection Systems" (21 October -1 November 2019)

Participants have the option of attending the whole course (and selecting this elective) or attending the elective on its own.
